Breaking Barriers: Oakmont Education Supports Free Menstrual Care Products for Ohio Students

Empowerment through access takes center stage as Ohio's HB 33 paves the way for change. The legislation directs the Department of Education and Workforce to allocate \$5 million for feminine hygiene materials in schools, heralding an era of menstrual equity.

The bill's impact is two-fold:

- Funds for Access: Schools will receive \$2 million for dispenser installation and \$3 million to reimburse costs for providing feminine hygiene products. Every girl in public and chartered nonpublic schools will benefit from grades 6 to 12.
- Dispensers in Schools: The Department is crafting an application process, with dispenserspecific funds set to reach schools by October 2023. This ensures that menstrual care products are accessible to all students promptly.

Oakmont Education has teamed up with Aunt Flow, a leading advocate for menstrual equity. Through this partnership (learn more at goauntflow.com/schools), Oakmont Education is dedicated to ensuring access to menstrual products for all students. This initiative aligns with our commitment to creating a positive, inclusive learning environment. Big Wins out of the State Biennium Budget

Oakmont Education played a pivotal role in advocating for and highlighting the significance of Dropout Prevention and Recovery (DOPR) and Career-Technical Education (CTE) programs and, thanks to this advocacy, DOPR schools providing in-house CTE and Credentialing programs can now:

- Qualify to receive state CTE funds in their first year, ensuring that resources are channeled effectively for positive educational outcomes.
- Qualify for the Quality Community Schools Funding from which they had previously been excluded.
- Increase the amounts of CTE funding for all CTE Categories for DOPR schools providing in-house CTE and Credentialing.
- Allow a portion of funding to be utilized post-grad and placement to support graduates after graduation.
- Expanded DOPR Testing Windows to two 10 week windows a year.

We applaud these advancements and recognize our partners who played a crucial role in advocating for the remarkable achievements within Ohio's school choice landscape. Particularly, we extend our appreciation to Dave Cash, CEO of Charter School Specialists, who comprehends the pressing nature of the dropout issue and its potential remedies.
